**Discussion (Summarized):** Mr. Greer explained this agreement was revised since the last meeting to show the developer increasing their contribution for the Northwest Hwy project from 2.5 million to 2.75 million. Mr. Greer stated the contract language is very similar to the previous contract but with one noted change being the language stating "2.75 million dollars or the cost of the project if less". Mr. Henry addressed the board giving a brief summary on the history of the Bellehaven project (attached). Mr. Henry stated his client would not have a problem striking out the portion saving "or the actual amount of the project if less" because they do not expect it to be less. Mr. Henry stated his client is comfortable with the 2.75 million dollar figure which is more than what the traffic impact study assigns to the Bellehaven site. Mr. Henry distributed a letter to the board from Mr. Dowdle showing how the contribution amount was figured (attached). Commissioner Johnson asked if any part of Elrod Rd was part of the traffic study that was completed. Mr. Dowdle replied Elrod Rd was analyzed for connection and to see if any improvements were needed and the study showed no improvements are needed. Mr. Dowdle went over the percentages projected for each road analyzed in the traffic impact study. Mayor Anderson and Commissioner Johnson both stated they feel like a lot of traffic from this development will utilize back roads to get to town rather than taking Hwy 96.

# Commissioner Johnson made an amendment to the motion for the city to have a traffic study done in whatever the timetable Mr. Carter says is available then compare and reconvene and move forward at that time. (No Second)

Mr. Henry stated he understands the concerns, but this is a POD and the time to vet further or challenge the correctness was at the Planning Commission level and the Planning Commission approved it. Mr. Henry stated certainly the city can obtain their own traffic impact study however his client is ready to move forward with the project and they had rather build their portion of Northwest Hwy and get going rather than have to wait around on a traffic impact study that may or may not differ by much. Commissioner Johnson stated he understands the developer being anxious but in speaking of the Planning Commission the difference is the BOC answers to the taxpayers and the Planning Commission is just appointed to a position. Mr. Carter addressed Commissioner Johnsons motion of a traffic study and stated he suggested it at the last meeting because Commissioner Johnson was getting ready to act in an arbitrary and capricious manner and the city would most definitely end up losing that lawsuit. Mr. Carter stated legally Mr. Henry is right about the law and that he sent an attorney-client memo dated May 23, 2024, and made it very clear what the law is and what his legal opinion is. Mr. Carter clarified what Mr. Henry said stating he said the city has a right to get a traffic study but also has a duty to vote on this contribution tonight. Mr. Carter stated the contribution offer tonight is 2.75 million for Northwest Hwy and the question is does the city wish to accept that or not. Commissioner Johnson replied in his opinion he would say not tonight because the traffic study doesn't take into consideration Elrod Rd and their development dumps out on Elrod Rd. Mr. Carter replied the traffic study says the affect on Northwest Hwy is 1.4-1.7 million and the offer is 2.75 million. Mr. Carter said he has made it very clear what he feels the board needs to do as well as staff has made it clear their opinions and if the board continues in this direction they will be doing it against all of staff. Commissioner Johnson stated he was told the developer had an initial meeting with the city and offered 5 million and asked if Mr. Carter could clarify. Mr. Carter replied that was the developers first proposal and it came before the BOC and the BOC voted to change the entire project by changing the entrances and the current design has more expenditures due to having to build a bridge, so it was the action of the BOC that resulted in the reduced contribution. Mr. Dowdle explained that with the prior staff they was asked if the Hwy 96 connection was eliminated and dumped about 75% of the traffic onto Northwest Hwy that would have included a larger contribution. Mr. Dowdle stated as the recalls they never formally agreed to any number because nothing had been finalized. Vice Mayor Butler stated the prior discussions and improvements was part of a new POD submittal and the board denied it and there was discussion that night from the board that they would prefer to see the access point on Hwy 96 instead of Northwest Hwy. Mr. Henry explained that what is on the agenda tonight is 10% more than what DR Horton had previously agreed too. Mr. Henry stated the city can take that extra \$250,000 and pay for a traffic impact study and pay for any improvements that the study suggests needs to be made on Elrod Rd. Mr. Carter asked Mr. Henry if he would agree to broaden the agreement to say the city could use the funds at the city's discretion for the Northwest Hwy project and/or any improvements the city believes is necessary to Elrod Rd. Mr. Henry replied yes, and that he would like to work with Mr. Carter on the language. Commissioner Hall stated he would be willing to accept the 2.75 million if a traffic study is done and the developer agreed to make any improvements deemed necessary to Elrod Rd. Commissioner Johnson asked Mr. Henry if they are willing to go over and above the 2.75 million if the traffic study comes back and says improvements need to be made. Mr. Henry replied no sir. Mr. Carter gave an example of a recent supreme court case. Commissioner McDonald stated he respects everyone's opinion, and his perspective is the city has an opportunity to commit outside dollars to a project that will benefit Fairview and he is not convinced a traffic study is off by the percentage that will be large enough to offset the additional 1 million dollars they are offering and in his opinion he feels the city should take this offer. Vice Mayor Butler stated one of the conditions for Planning Commission approval was a phase traffic study and asked if that is still the intent. Mr. Owen stated he believes that condition would still exist with each completed phase of the development. Mr. Henry stated the way the development agreement reads is that the developers contribution today would satisfy the two conditions added by the Planning Commission relative to those items on pages 13 and 14. Mr. Henry stated it is their understanding that the traffic impact study updates were to determine whether or not a traffic light is now triggered at the intersection of Northwest Hwy and Hwy 96. Mr. Henry stated the way the agreement is structured is, so

the city don't have to worry when the traffic light is triggered because the contribution includes funds for the traffic light at the intersection. Mr. Owen clarified for the board the impact percentages on the roads based on the traffic impact study and explained the level of services. Vice Mayor Butler asked Mr. Daugherty if the city is financially prepared to absorb the rest of the project cost. Mr. Daugherty replied the city is very prepared. Vice Mayor Butler also asked Mr. Henry if they are comfortable adding force majeure language to the agreement. Mr. Henry replied absolutely.

Vice Mayor Butler made a motion to amend to include the language to allow payment in full at final plat and to allow proceeds of that to go towards design and engineering work for this project, to strike the "or actual amount" from the beginning part of the agreement, and to add force majeure language. Second: Commissioner McDonald

Commissioner Johnson asked who from the city met with the developer to see if they would add additional funds to their contribution and if the board authorized it. Mr. Carter stated he called the developer and told them it appeared the 2.5 million didn't appear to have the votes based on the last meeting and asked if they would consider increasing their offer. Mr. Carter stated the developers obligation is to pay for their impact and the traffic study that was done and accepted by the Planning Commission said the impact is between 1.4 and 1.7 million depending on the exact improvements and the developer has the ability to offer more than that which is what is being done.

#### Commissioner Hall made a motion to amend to accept the 2.5 million, take \$250,000 do a traffic study on Elrod Rd if there is any expense over \$250,000 he would like to see the developer step up to the plate and take care of it. Second: Commissioner Johnson (later withdrawn, no vote taken)

Mr. Owen suggested if the city wants to have an additional traffic study done to do the full evaluation instead of just specific intersections. Mayor Anderson clarified even if Mr. Halls motion gets approval the developer is not willing to contribute more than 2.75 million dollars. Mr. Henry stated that is correct. Mr. Johnson and Mr. Greer discussed right-of-way acquisition for the alignment of Northwest Hwy. Mr. Johnson asked Mr. Greer how he feels about the developer completing their portion of the improvements instead of making a contribution. Mr. Greer replied he would like for the whole project to be done as a whole, not by pieces. Mayor Anderon stated the Planning Commission agreed to approve this with a development agreement and asked how it will work if a development agreement is not signed. Mr. Carter replied if the development agreement that allows them just to improve in front of their property and board would have to do one or the other. Mr. Greer read aloud Ms. Senyard's motion from the Planning Commission

meeting which said. "I propose we amend to require a development agreement that the Board of Commissioners must approve prior to any final plat being recorded regarding road improvements and the developers share thereof". Mr. Henry stated the Planning Commissions recommendation condition of approval was in light of the fact the city is pursuing improvements to Northwest Hwy, that is why the condition was made and if there is another figure someone has in mind besides the 2.75 million that is listed in the agreement he would like to take that back to his client. Mayor Anderson stated in her opinion the original ask of improvements all the way to Hwy 96 at approximately 5 million is what should happen. Commissioner Johnson and Mr. Hall withdrew the motion and second for the amendment.

#### G. Resolution 28-24, A Resolution authorizing the Mayor to execute an agreement between Locality Media, Inc. DBA First Due and the City of Fairview, Tennessee. (Fire Chief)
