Mr. Elsworth explained this is not a traditional storage facility, it would be one building and everything would be temperature controlled. Mr. Elsworth explained that this property is 4.25 acres, and they would only use half of the property. Mr. Greer explained that there are only three zoning districts that would allow Mr. Elsworth to accomplish what he would like to build.
