A. Ordinance 2024-13, An Ordinance to amend the Zoning Ordinance of the City of Fairview, Tennessee, by rezoning 5.60 (+/-) acres of property located at the Southeast corner of the intersection of Fairview Boulevard and Cumberland Drive, consisting of Williamson County Tax Map 046, Parcel 108.05, from RS-40 (Single Family Residential) to CMU (Commercial Mixed Use Zoning District), Property Owner: S&W Fairview Partners. (City Planner)

Discussion: Mr. Greer stated this rezoning request is for a 5.6 acre parcel located at the southeast corner of Fairview Blvd and Cumberland Drive. Mr. Greer stated this property is currently zoned RS-40 and the requested zoning is CMU. Mr. Greer stated the properties to the east, south, and north are zoned RS-40 and the property to the west is zoned R-20. Mr. Greer stated staff gives a favorable recommendation for this rezoning and this rezoning received a positive recommendation from the Planning Commission. Mayor Anderson stated she feels this would be a perfect place for a child enrichment center and a coffee shop.

B. Ordinance 2024-14, An Ordinance to amend the Zoning Ordinance of the City of Fairview, Tennessee, by rezoning 37.52 (+/-) acres of property located at 2451 Fairview Boulevard, consisting of Williamson County Tax Map 046, Parcel 087.00, from CG (Commercial General) to RM-8 POD & RS-10 POD, Property Owner: Barkeast, LLC. (City Planner)

Motion to approve on first reading and add to the August 13th Planning Commission agenda for review and reconsideration: Commissioner Johnson Second: Commissioner Hall

Discussion: Mr. Greer stated this project received a 5-4 vote at the Planning Commission for a negative recommendation. Mr. Greer explained that after the Planning Commission meeting Mr. Pape sent him a letter stating he had further discussions with the applicant and feels better about this project moving forward. Commissioner Johnson stated good discussion was had during the work session and suggested sending this item back to the Planning Commission on August 13th for reconsideration before coming back to the BOC for final reading on September 5th. Commissioner McDonald stated he believes this is the best course of action but still has opposition on the sizes of the interior roads. Vice Mayor Butler stated he feels this does not meet the sub regs or the intent of the 2040 plan. Mayor Anderson stated she appreciates the applicant adjusting the project several times. Mayor Anderson also stated she is encouraged by the driveways being increased to 25 feet, the single family lots being made larger, and the evergreen buffer around the project. Mayor Anderson stated she encourages this product to be sold instead of rented. Vice Mayor Butler clarified that the lot sizes did not increase from what was submitted to the Planning Commission and suggested the applicant meet with surrounding property owners.
